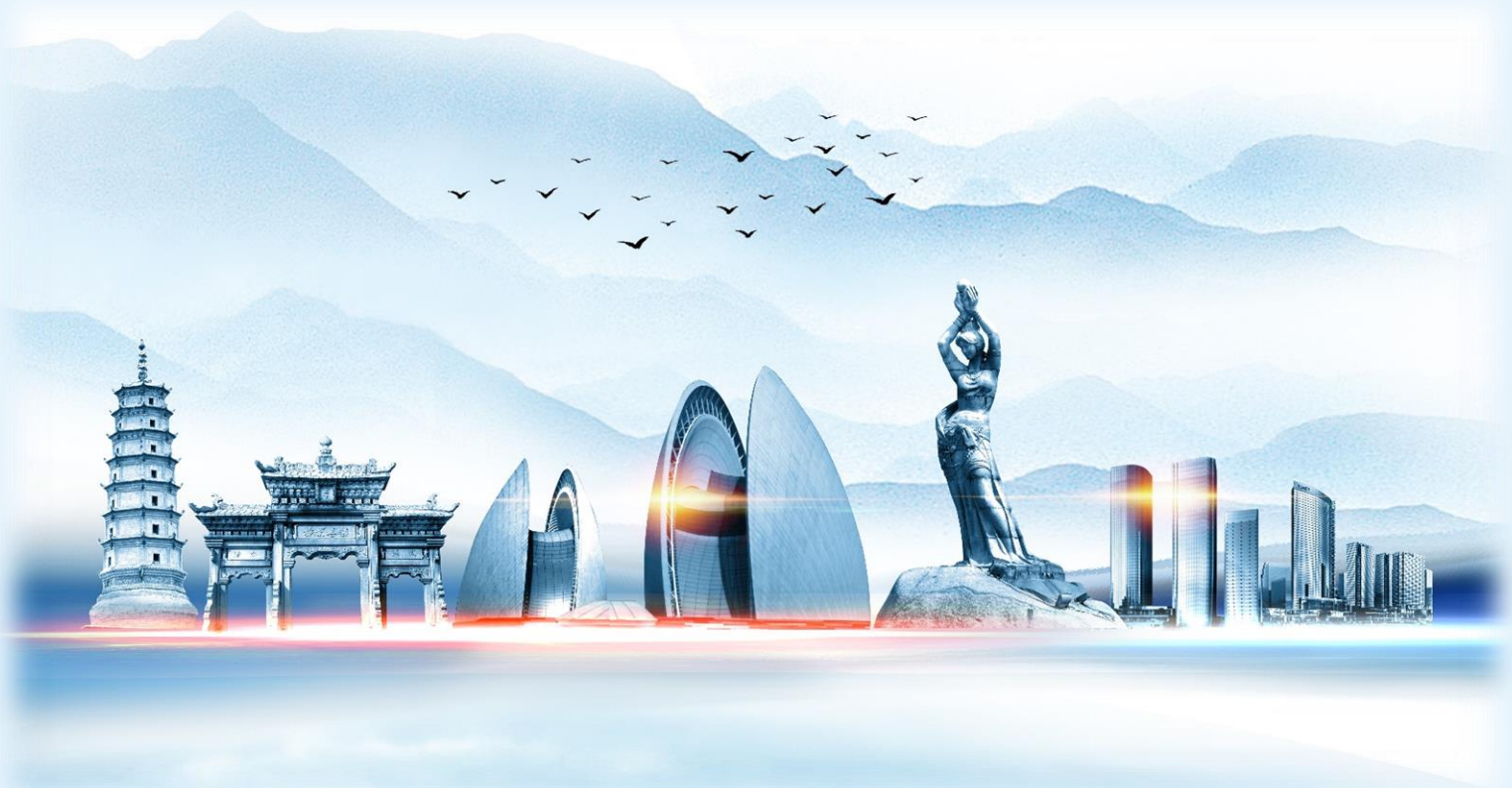

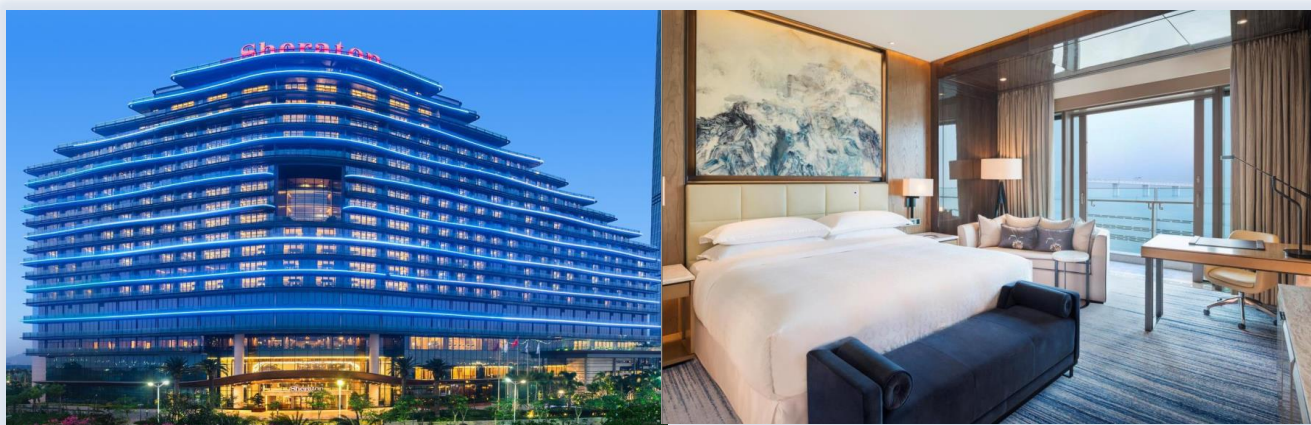

❖ Kaiping Diaolou

Kaiping Diaolou located in the southwestern part of the Pearl River Delta is listed by the Chinese State Council as a key cultural relic protected by the state. Its total number



amounted to 3,300 in the peak years and now the registered number is 1833, and twenty of the best ones are inscribed on the World Heritage List by UNESCO. These buildings take three forms: communal tower jointly built by several families for use as temporary refuge, residential tower built by individual rich family and used as fortified residence, and watch tower for guarding against bandits.

❖ Liyuan

Liyuan has the reputation of “small view garden”, and it is the representative of “the combination of small bridges, running water and people”. The layout of the garden is divided into three areas: large garden, small garden and villa area, which are separated by the man-made river and walls, and also are connected by bridges and channels. The famous calligraphy in the engraving have added a rich cultural connotation to the Liyuan Garden. The buildings in the villa area are the combination of the Chinese and Western architecture elements and are the daily living place of the garden owner. Liyuan presents a unique architectural beauty that is the first-class in the privately-built gardens of the overseas Chinese.
