What can you tell us about the Study Question preparation/submission process within your group? Please include details on the participation of members from different professional backgrounds and encouragement of young member participation.

AIPPI-US is a division of AIPLA, and the drafting and approval process of the responses were passed through different levels of the AIPLA organization.

In 2019, we had from five to ten members of AIPPI-US on each Study Question Drafting Committee. We solicited participation amongst all members of the AIPPI-US organization, including personal invites to young members. The members included all levels of experience and backgrounds.

The Drafting Committee prepared a preliminary draft response that was circulated to two or three relevant Substantive Committees for AIPLA for edits, comments and feedback. A revised draft response was provide to AIPPI-US Steering Committee for further review and approval. An approved draft was sent to AIPLA Board of Directors for final review and revisions.

The leadership of the AIPPI-US drafting Committee finalized the responses that were sent to AIPLA ExCo for final approval.

Q6

How did the NRG and its members participate in international AIPPI Committees work in 2019?

As noted above, AIPPI-US members were on all Standing Committees and five of six Statutory Committees. Our members included seven Chairs and nine Vice-Chair / Secretaries. We encouraged members to also sign up as observer status. We were unable to obtain from AIPPI a listing of our US members that signed up as observers and what committees they were observers for. We also had three members in leadership roles of the Study Question Working Committees.
