In this interview, Kevin (a Young Member) and Maria (a long-time Congress attendee) quiz one another on their AIPPI Congress experiences

Maria, what keeps you coming back to AIPPI World Congresses year after year? What value do you get out of belonging to AIPPI?

The AIPPI World Congress is enriching, not only personally but professionally as well. Every meeting provides lessons in many aspects, including negotiation skills. These skills are useful for everyday situations. Each year I look forward to seeing my colleagues and discussing new, relevant topics during the workshops.

I believe the mission of AIPPI is important to help develop and improve IP protection both nationally and internationally. The Congress provides a space annually to meet and talk through developments.

Kevin, how have your first AIPPI Congresses gone?

I have attended two AIPPI World Congresses – and they were both virtual (2020 and 2021). I can recall that I was quite nervous in the first couple of sessions in front of the camera. But the hosts and cohosts were very skilful at doing ice-breaking activities and it soon enabled me to comfortably express myself in online discussions.

How do the virtual Congresses compare to the in-person Congresses you previously attended Maria?

I think Congresses in person are always better, as we need the "human touch" and interaction. Nevertheless, COVID showed us

that we can adapt to any situation. COVID changed the ways we have to communicate and taught us how to create new environments and use technology more. That said, I am looking forward to San Francisco next year and being able to see everyone in person.

Maria, what was your most unforgettable moment this Congress?

One of the most memorable parts of the Congress this year was when I was Vice Chair for one of the Study Questions and the discussion went over 5 hours! I was taking the minutes and representing my National Group, which was quite difficult to manage, but it showed me that any task is possible when there is teamwork. I think the discussions are interesting as they provide a space where everyone can expand on a point of view and give their opinions. Although it was challenging, in the end we were able to come to a consensus.

And what were your highlights, Kevin?

The Young AIPPI Forum at the World Congress this year had a set main theme which was the "Resilient Professional." A training firm helped to organize a half-presentation and half-interactive seminar. We talked about possible ups and downs in career development, and collaboratively found better solutions to these challenges. Simply put, it was like how we can address hardships and pressures and then turn them into positive momentum to help us grow.

Besides this, the Young AIPPI members Advisory Committee (YAC) hosted two AIPPI Cafés during the World Congress. Maria, what tip would you give "newbies" to get the most out of attending an AIPPI World Congress?

I would tell "newbies" to not be afraid of asking questions. The AIPPI structure may be complex to understand at first, and therefore newbies could use the guidance of someone experienced to get the most out of the association and give back the same. By asking questions, I believe that newcomers would gain more from the experience. At the Congress there is a wonderful atmosphere made up of professionals and it is great for networking.

Kevin, is there anything else you think is important for young attendees to know about AIPPI and the Congress?

Overall, I find that AIPPI offers opportunities to sharpen professional skills and to obtain necessary practice tips. It also serves as a great networking platform where you can find practitioners who possess an even greater passion for IP than you do. I felt lucky to be part of it. I advise every one of us to make the best use of all the resources in the association.







Jan Bernd Nordemann





The following edited exchange has been extracted, with permission, from the podcast "International Law Talk" by Wolters Kluwer International.

In this episode, Christian Czychowski and Jan Bernd Nordemann, both partners at NORDEMANN, a German IP Law Firm, discuss Law of Raw Data.

Recently their new book about this topic was published by Wolters Kluwer, as part of the AIPPI Law Series. It provides an overview of the Law of Raw Data and the legal concepts in many jurisdictions around the world, including 30 countries worldwide.

Christian

Data is used in many circumstances. To give you some examples, just think about a consortium of a couple of industry partners, a university and a city. Everybody's talking about e-mobility. So let's imagine that the city has a lot of data for certain travel intersections, namely traffic light data. That's certainly raw data. It's not personal data. And that industry consortium wants to use this data, for example, to enhance the traffic in that city. The cars could then communicate with each other. This is just one case example where contracts have to be concluded about raw data.

One more example. Imagine a manufacturer of machines that uses data in the production of e.g., sheet metal, at worldwide factory outlets. He has developed a method that enables such a production company to monitor the operation of these machines from its headquarters, not from each factory. So there has to be a flow of data from the factory to the headquarters, to the operator, to a service company etc. Of course, such data, which is normally not **Christian** personal data, can be of great interest not only to the manufacturer, but also for the customer in order to optimize his own processes. These are just two examples. You can see Jan, it sounds interesting from a lawyer's point of view, I would say, to think about what this means, in terms of legal questions.

Jan

You use the examples of collected traffic light data or machine data. But beyond factual issues, how about the legal issues? Are there any legal issues? Or is this more something that only plays on the factual side of things?

Christian

Yes, there are a number of legal questions around this "factual possession", let's call it that way. I am a little bit careful about

phrasing the way someone uses data, has data or possesses data. When you talk about this really brand new field of law, we lawyers tend to use old fashioned phrasings. But actually, it's not that we talk about potatoes or ice cream that you can possess, and own, and transfer. You talk about immaterial things that we don't know what they are. So, to answer your question, yes, there are legal questions.

First of all and most important, what is raw data in legal terms? As I already said, if you talk about it, you tend to use words that you are used to from the material world. So, is there any kind of property right in this unstructured or raw data? We have seen that many lawmakers have decided that there are no such property rights. So, we don't have anything to own or to possess. It's more and more important that you have contracts governing this factual ownership.

Are there rules for contracts if you don't know what the contents of that contract are? That's another question. And apart from that contract, but beyond the contractual relationship, how can there be legal protection, for example, to control access, as I said in my example, for the manufacturer of the sheet metal? How can the customer urge the manufacturer to grant him access? I would say Jan, there will be plenty of questions coming up and I would imagine that we don't have a solution for all of them.

Jan

Are lawmakers starting to legislate and recognize ownership in raw data? Or what's the trend here in legislation on a worldwide basis?

Yes. It's very interesting to see that there have been discussions going on in the major jurisdictions throughout the world, in the last two years, I would say. And at least in Europe, and as far as I can see, also in North America and in Japan, they have come to the conclusion that they will probably not regulate or introduce any kind of ownership, some sort of new IP right, because there are too many questions, unsolved, too many problems that then will evolve.

China is a little bit different as I understand it, they have introduced some kind of ownership, at least for certain data. But the trend is clearly going to a contractual rule and to rules of access. The question of ownership does not seem to be on the table currently. They leave us practitioners with the easy call, don't worry, do it with contracts.

Christian

So to wrap this up, we've now talked a little bit about the interesting legal questions. But Jan, tell us why did we all end up discussing this? There was some background for it within AIPPI. How did it come about?

Jan

Yes. AIPPI also thought that IP rights in data was an interesting issue. So they made this an AIPPI Study Question. And all those who know AIPPI, also know that in the case of a Study Question, a questionnaire is sent out to the entire world, to all the national groups of AIPPI. And for the Study Question of IP rights in data, more than 30 national reports came back to AIPPI. Afterwards, a Resolution was passed at the AIPPI World Congress Online 2020. You can look at all these materials and access them through the AIPPI website. Very interesting, I think, for all the lawyers that need to know the law of raw data beyond their own national borders in an international context.

And from this great AIPPI work, we thought we should also make a book. Christian and I then started to gather national chapters from different countries around the world, from the most important jurisdictions, describing the law of raw data. There's also a chapter I would like to mention on international conflict of laws in law of raw data, which may also be interesting to read for those who work in law of raw data in an international context.


